NOTES TO THE PROXY FORM

- You are entitled to appoint another person as your proxy to exercise all or any of your rights to attend and to speak and vote at the meeting. You may appoint more than one proxy in relation to the meeting, provided that each proxy is appointed to exercise the rights attached to a different share or shares held by you.
- A proxy need not be a shareholder but must attend the meeting to represent you. If you wish to appoint someone other than the Chairman of the meeting, insert the name of the person you wish to appoint in block capitals in the space provided. If the proxy is being appointed in relation to less than your full entitlement, please enter in the box next to the proxy holder's name, the number of shares in relation to which the proxy is authorised to act. If that box is left blank, the proxy will be deemed to be authorised in respect of your full voting entitlement. Where you appoint someone other than the Chairman, you are responsible for ensuring that they attend the meeting and are aware of your voting intentions. A vote withheld is not a vote in law and will not be calculated in the calculation of votes for or against the resolution. If you give no voting instruction, your proxy will vote or abstain from voting at their discretion. Your proxy will also vote or abstain from voting as they think fit in relation to any other matter which is put before the meeting. If you wish your proxy to make any comments at the meeting on your behalf, you will need to appoint someone other than the Chairman and give them the relevant instruction directly.
- You may appoint more than one proxy provided that each proxy is appointed to exercise the rights attached to a different share or shares held by you. If you wish to appoint more than one proxy, each proxy must be appointed on a separate proxy form, indicating on each copy the name of the proxy you wish to appoint, the number of shares in respect of which the proxy is appointed and the way you wish them to vote on the resolution that is proposed. Please indicate by ticking the box provided that the proxy appointment is one of multiple appointments being given. All proxy forms must be signed and should be returned together.
- To be effective, this proxy form, fully completed, together with the power of attorney or any other authority under which it is executed (or a notorially certified copy), must be lodged with Equiniti Limited at Aspect House, Spencer Road, Lancing, West Sussex BN99 8LU, not later than 11.00 a.m. on 20 November 2014. You can submit your proxy electronically at www.sharevote.co.uk where full details of the procedure are given.
- If the shareholder is a corporation, this proxy form should be executed under its common seal, or signed on its behalf by a duly authorised officer or attorney.
- In the case of joint holders, the signature on this proxy form of any one holder will suffice but where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding, with the first named being the most senior.
- Any alteration to this proxy form should be initialled.
- The completion and return of this proxy form will not prevent a shareholder from attending the meeting and voting in person.
- If you submit more than one valid proxy appointment in respect of the same share or shares the appointment received last, before the latest time for receipt of proxies will take precedence.
- Addresses (including electronic addresses) in this document are included strictly for the purposes provided and not for any other purposes.
- Pursuant to regulation 41 of the Uncertificated Securities Regulations 2001, entitlement to attend and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the register of members of the Company at 6.00 p.m. on 20 November 2014, or if the meeting is adjourned, in the register of members at 6.00 p.m. on the day which is two days before the day of any adjourned meeting. Changes to entries on the register of members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.
- CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so for the meeting and any adjournment(s) of the meeting by using the procedures described in the CREST Manual. CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.

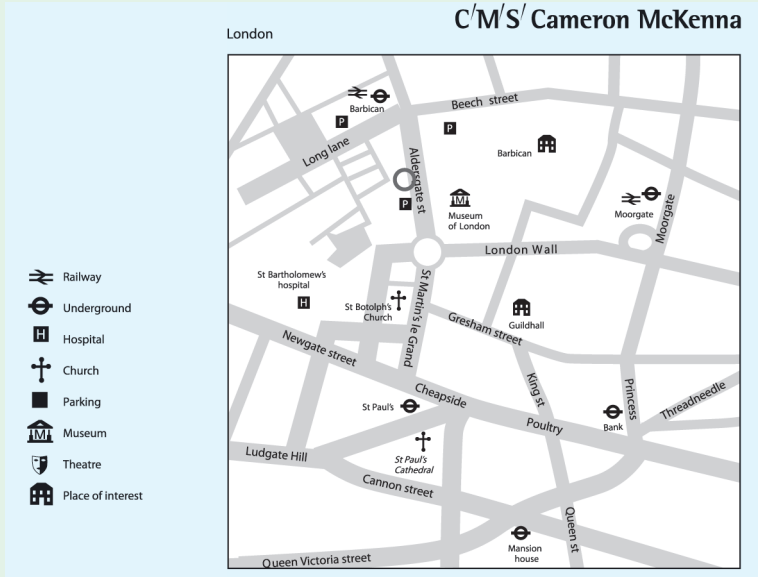
